

# Harrison Park Cabin Rules and Regulations



## Cabin Reservation

The Harrison Park Cabin can only be reserved by calling 519-371-9734. Full payment for a cabin reservation is required at time of booking using a credit card only (Visa, Mastercard).

The minimum age for cabin rental permit holder is 18.

Reservations have a minimum stay of three (3) nights.

- Check-in after 4:00 pm daily
- Check out by 11:00 am daily

Week-long cabin rentals:

- Check-in Sunday after 4:00 pm
- Check out Saturday by 11:00 am

The maximum length of stay at the Harrison Park Cabin is fourteen consecutive nights.

A \$20 administration fee is charged per requested change to an existing reservation in accordance with Policy FPR-002.

A \$250 damage deposit is required on the day of arrival using the cabin rental permit holder's credit card (Visa, Mastercard).

All campground reservation cancellations are subject to Policy FPR-002. All cancellations must be completed online using the prescribed form.

## Registration

Registration occurs at the campground registration booth at Harrison Park at 75 2<sup>nd</sup> Avenue East for the Harrison Park Cabin reservations.

- All cabin guests must arrive to register and obtain a cabin rental permit no later than 8:00 pm.
- Check-in time starts at 4:00 pm; Check-out time ends at 11:00 am.
- One (1) vehicle is allowed to be parked on the cabin site. Licence plate information for the vehicle parked at the cabin site will be registered against the cabin rental permit.

- Campers may purchase parking passes for additional vehicles that can be parked at a separate designated parking lot.
- The maximum number of cabin guests permitted at any time is six (6) people.
- No additional tents or dining tents are permitted to be erected on the cabin rental site.
- Please note that the campground registration booth does not accept cash and all campground registration booth purchases will require a credit card (Visa, Mastercard) or debit card.

## **Visitors/Guests**

- All visitors/guests of cabin rental permit holder must register at the campground registration booth.
- Visitors/guests must leave the campground by 11:00pm.
- Visitor/guest vehicles must not park in campground. Alternate parking in the park is available and parking passes can be purchased by visitors/guests at the campground registration booth for a designated parking lot for cabin rental permit holders and their visitors/guests.

## **Alcoholic Beverages**

- Confined to cabin and adjacent grounds only.

## **Pets**

- Pets are NOT permitted during your stay at the cabin.

## **Quiet Time**

- 11:00 pm to 8:00 am daily.
- Excessive noise or abusive language will not be tolerated at any time.
- Courtesy and consideration for all campers must be exercised.

## **Cabin Regulations**

- Smoking and vaping are prohibited inside the cabin.
- Cooking in the cabin is only permitted on the provided electric cooktop or microwave.
- Please place garbage and recyclable items in the containers provided.
- Outdoor campfires must be inside the rings provided. There is a limit of one (1) campfire ring for cabin rental permit site.

- There is a limit of one (1) picnic table for cabin rental permit site.
- Please do not place a grill on a picnic table when hot or while being used to cook.
- Please supervise your children at all times.
- Absolutely **NO** outside firewood is permitted to be brought to the campground. Firewood is supplied for a nominal fee and is available at the campground registration booth.
- Obey all signs in the campground and observe the posted speed limit.
- Vehicles must remain on hardened surfaces, paved and gravel roads.
- The use of ATVs, dirt bikes, or other off-road vehicles is not allowed.
- Rowdiness, drunkenness and intoxication are absolutely prohibited.
- Do not move to campsite without permission.
- Cabin rental permit holders are responsible for any damages caused to the cabin.

### **Cabin Amenities**

- Cabin rental comes with two double beds and a double pull-out sofa mattress.
- Cabin is equipped with electricity, microwave, coffeemaker, fridge, sink, range top, fire extinguisher, dustpan, broom, and dining table with six chairs.
- Basic kitchen inventory includes: cutlery, dishes, mixing bowls, frying pans, cups, mugs and miscellaneous kitchen utensils.
- A charcoal camp BBQ is supplied as part of the cabin rental permit and can be found outside immediately adjacent to the cabin.
- There is one (1) campfire ring for the cabin rental permit site.
- Washrooms with showers are a short walking distance from cabin site.

### **What to Bring**

- Cabin renters will need to bring their own personal items including but not limited to: sleeping bags or bedding, pillows, cookware, food, charcoal (for cabin BBQ and matches/lighter).

### **Park Staff**

- City of Owen Sound campground management staff and/or assigned Security Service officers reserve the right to evict anyone from the campground for failure to observe the campground rules and regulations.
- No refund will be provided if a camper is asked to leave for non-compliance with the campground rules in accordance with FPR-002.
